**Subject:** Voter Roll Status Report

Hello Secretary LaRose, SOS Staff Members, Senators Gavarone, Roegner, Lang, McColley, and Representative Plummer,

This is another in a series of monthly voter roll status reports that I started sending several months ago. Last month I emailed Secretary LaRose and some members on distribution about 472 voters that matched ODH death records. This month we have 468 ODH matches, a small improvement. If I can do anything to help you fix these records, please let me know. The number of duplicates based on last name, first name, middle initial, and birth date is significantly lower since the last report, down to 4,214 from 9,149. Kudos on that, but we're not making as much progress on other categories of duplicate records, which should be relatively easy to resolve.

To help in that regard, this month I am presenting a small sampling of the 1,327 duplicate voters where multiple records have the **same first name, address, and date of birth.**

These are all clearly duplicates with minor variations in their names that should be easily resolved by the county Board of Elections when you bring the issue to their attention. The full list of **1327 duplicates** is on my website <https://ohiovotescount.com/duplicates-on-first-name-address-dob-voter-registration-issues-january-2026/>. I've organized the records by county to make it easy for SOS staff to copy/paste/send the questionable records to the county BOE. Personally, I've had success emailing such lists to my county BOE, but I am not able to manage that task across 88 counties, and after all, it is something the SOS office is responsible for.

Secretary LaRose with respect to some of your recent comments, I have other "hobbies" and would like nothing better than to spend more time with those. However, clean voter rolls are critical to election security, and I've made it a priority to do what I can to help your staff of "professionals" resolve the issues I know about.
